Online Safety

Dear Parents,

Safer Internet Day is celebrated globally in February each year in over a hundred countries to promote the safe and positive use of digital technology for children and young people and inspire a national conversation. Coordinated in the UK by the UK Safer Internet Centre, the celebration sees hundreds of organisations get involved to help promote the safe, responsible and positive use of digital technology for children and young people.

Safer Internet Day is a fantastic opportunity to reflect as a family about how you can use the internet and technology safely, responsibly and positively. Whether you are a parent, grandparent, foster carer, aunt, uncle or older sibling – we can all play a role in empowering children to enjoy their time online!

Key Message:

This year, the UK Safer Internet Centre is particularly focusing on how consent works in an online context and exploring how young people ask, give, and receive consent online. This could be in their friendships or relationships, how they take and share images and videos or how they manage their privacy and data.

Useful Conversation Starters:

Get the conversation started on a + What do you like most about the internet and why? What's positive note with your favourite game/app/site? these conversation How does going online make you feel? starters! → How does the internet/technology make your life better? What could you do if being online is making you feel worse rather than better? What is different about talking online to someone compared to talking face to face? Is there anything that is the same? Can people say/do whatever they want online? Why/why Do you know where to go for help, where to find safety advice and how to use safety tools on your favourite apps and games? What is okay/not okay to share online? Why? What could you do if you saw a friend online needed some help or support? Talk How do you stay safe online? What tips do you have and about where did you learn them? Help me! Can you show me how to do something better/safer online? safety How many things can we share online? (pictures, comments, personal information, opinions etc.) What do we like to share online? What should we not share online? What should we do before sharing things online? What do we do if someone shares something about us that we Talk about Can your parents/ carers share things about you online and vice sharing online

- How do we say no/not give consent?

Safer Internet Day at Mosborough

As part of Safer Internet Day, our Online Safety Champions will be visiting all classes in school. They will give a short presentation about the current online issues which they feel are important. They will then launch a whole school competition to design a poster promoting online safety which can be displayed in classrooms across school. They will pick one winner from each phase. In addition, we will hold assemblies to further explore this year's theme and all classes will participate in lessons which are linked to online safety during the day. This will involve whole class discussions about how we behave online.

Acceptable Use Policies for Children and Parents

This week, you will receive a copy of our both our Acceptable Use Policy for Parents and for Children (this will vary depending on the Key Stage your child is in). The policy helps school to ensure that young people stay safe when using the internet and that our school systems are protected from misuse which could put systems and users at risk.
